APPLICATION GUIDELINES FOR EXPLORATORY RESEARCH GRANTS

About the Academic Forum for the Study of Gambling (AFSG)

The AFSG is a group of academic researchers in the UK dedicated to advancing the research needed to effectively prevent, reduce, and address gambling harm. The purpose of the AFSG is to act as a coordinated body to assert the importance of rigorous, independent research to prevent, reduce, and address gambling harm in the UK.

To accomplish its aims, the AFSG engages in a number of activities including, but not limited to:

- Responding to or initiating calls for evidence;
- Providing seed grants for promising research;
- Supporting independent gambling conferences;
- Public engagement; *and*
- Providing support for early-career researchers.

All AFSG activities and grants are funded from [regulatory settlements for socially responsible purposes](#). The Gambling Commission reviews and approves proposals for destinations of regulatory settlements. Funds are administered by Greo.

On behalf of the AFSG, Greo is accepting applications for **Exploratory Research Grants**.

APPLICATION GUIDELINES FOR EXPLORATORY RESEARCH GRANTS

PURPOSE

To develop capacity for research by providing funds to conduct preliminary/exploratory research that will encourage innovation and increase the capacity of researchers to compete successfully for other, larger, research awards and other funding sources. Such projects can include, but are not limited to:

- Secondary analysis of existing data
- Pilot and feasibility studies
- Development or testing of instruments
- Development of research methodology
- Small, self-contained research projects

ELIGIBILITY

Applicants must be members of the AFSG. AFSG membership is free-of-charge and open to anyone affiliated or working with a UK university who is interested in conducting or co-creating independent research on gambling-related harm. See the [AFSG Membership webpage](#) for further details.

Funding must be administered by a UK university.

CONDITIONS

The research project under consideration must demonstrate that it is rigorous, independent research that directly or indirectly informs efforts to address gambling-related harm.

Applicants are asked to declare all other funds they have secured that will support the proposed research. Preference will be given to projects that have no existing funding.

The AFSG encourages the involvement of Experts by Experience or Lived Experience Experts in all stages of the research process. Applications which demonstrate involvement and specific considerations of EBE/LE will be given preference during the adjudication process.

VALUE AND DURATION

Three grants are available. Each grant can last up to 12 months.

APPLICATION PROCESS

Expression of interest (EOI): Please send an email to afsg-funding@greo.ca by October 25, 2022 at 5:00pm (GMT) indicating: (1) which award you are planning on submitting for; (2) a list of anticipated project team members; (3) if you are an early career researcher (see footnote 1, page 4); and (4) the university to which funds would be distributed through (if successful). The email subject should be "EOI: AFSG [Minor/Major] Exploratory Research Grant".

Full application: Applicants should prepare an application according to the instructions below and email it as a single PDF to afsg-funding@greo.ca by 25 November 2022 at 5:00pm (GMT). The email subject should be "APPLICATION: AFSG [Minor/Major] Exploratory Research Grant".

Major Exploratory Research Grant

One Major Exploratory Research Grant is available. It is valued at up to £80,000 and is intended to be used for a major project and is open to all researchers.

Minor Exploratory Research Grants

Two Minor Exploratory Research Grants, valued at up to £25,000, are available. These grants are intended to fund smaller exploratory research. Preference for these grants will be given to early career researchers.¹

Timeline

11 October 2022 Call for applications announced

25 October 2022 Expression of interest (EOI) deadline

25 November 2022 Application submission deadline

13 January 2023 Notification to applicants
(funding to commence soon after)

31 January 2024 Project completion date

¹An early career researcher is a researcher within seven years from the date of their first research-related appointment, minus eligible delays in research. Research-related appointments are defined as those where the individual has the autonomy to conduct research independently and all eligible leaves (e.g., maternity, parental, medical, bereavement) are credited as twice the amount of time taken, and professional leaves (e.g., training, sabbatical, administrative) are not credited.

PROJECT REQUIREMENTS

Pre-registration

Applicants should include a plan to pre-register their research question or hypothesis in an open, online registry. If pre-registration of the hypothesis is not appropriate, please explain why it is not.

Deliverables

Upon completion of the project the applicant must complete a summary report of findings that will be posted to the AFSG website with a link to Greo's [Evidence Centre](#). The summary report will undergo peer review and will be posted after any revisions have been completed. Copyright remains with the author. A Creative Commons CC-BY-NC-ND license will be applied. Authors are encouraged to submit a separate article to an academic journal. All project outputs should include the following text: "The author(s) wish to acknowledge the Academic Forum for the Study of Gambling (AFSG) for providing funding for this project [insert project number here]. The views expressed are the views of the authors and do not necessarily reflect those of the AFSG."

Resulting Data

If data are collected, the dataset and accompanying documentation must be deposited in a publicly available data repository such as the [Open Science Forum](#), [UK Data Service](#), or the [Greo data repository](#) within one year of project completion. In the spirit of open science, the data and metadata will be made available for review and secondary analysis.

2 ABSTRACT

Please provide a summary abstract (max. 300 words) that includes:

- 1 PURPOSE AND SIGNIFICANCE;
- 2 RATIONALE;
- 3 METHODOLOGY; AND
- 4 POTENTIAL IMPLICATIONS OF THE PROPOSED RESEARCH.

3 RESEARCH PROPOSAL

The project proposal section requirements are detailed in Appendix A: Evaluation Criteria. The proposal is not to exceed four-single spaced pages, minimum 11 pt font size (excluding references and appendices).

4 SYSTEM SUPPORT, ACCESS, ETHICAL CONSIDERATIONS

System support

Describe the academic/research support available from your institution. Include both financial and 'in kind' contributions, if applicable.

Feasibility

Please describe any potential barriers to completing your project and how you plan to overcome them. For example, if the proposed research will require access to gambling sites, suppliers, slots laboratory or staff, have you gained access/approval?

Ethical considerations

Indicate whether ethics approval for the project will be needed. Where required, applicants must obtain research ethics approval and funding is conditional upon ethics approval being granted.

5 APPLICANT'S CURRICULUM VITAE

Submit the most current version of the Principal Investigator's curriculum vitae.

6 CONFLICT OF INTEREST STATEMENT

Please include a Conflict of Interest statement pertaining to financial support during the past five years. This should include any funding received, employment with, or financial or non-financial interests that could be reasonably perceived as directly or indirectly influencing the work described above. If the applicant is affiliated with a stakeholder organisation (e.g., third sector charity), a transparency statement for the organisation must also be provided

7 APPENDICES (IF APPLICABLE)

Additional information may be submitted to support the application. Appendices are limited to a maximum of five (5) pages. When including more than one appendix, please combine into a single PDF.

8 BUDGET AND TIMELINE

Complete the downloadable [budget summary and timeline template](#). Complete the budget summary template. Allowable budget expense categories include personnel, equipment, supplies, participants, and travel expenses. Refer to the [expenses guidelines](#). Include a timeline for the proposed research.

In this section, please declare all other funds secured that will also be used to support the proposed research. If there are none, please declare.

Full Application

The full application package should be sent as one continuous PDF email attachment to afsg-funding@greo.ca by November 25, 2022, at 5:00pm (GMT). The email subject should be “APPLICATION: AFSG Major Exploratory Research Grant” or “APPLICATION: AFSG Minor Exploratory Research Grant”.

Evaluation and Scoring

Following an initial screening for completeness, Greo will send the applications to reviewers. These reviewers may be internal or external to the AFSG. Provided no conflicts of interest exist (see conflicts of interest section below) the reviewers will review the applications according to the criteria described in Appendix A: Evaluation Criteria. Reviews will be forwarded to a working group of at minimum two AFSG members (appointed by the AFSG Co-Chairs) who will review the evaluations submitted by the peer reviews and make a decision.

Once the Forum has determined the successful applicants, Greo will administer and manage the grants. Text-based comments will be shared with all applicants, but not numeric scores. Unsuccessful applicants will be encouraged to resubmit to the next funding call using feedback from the peer reviewers to strengthen the proposal.

Successful Applicant Presentations/Webinars

After the successful applicants have been selected, they will be invited to present their research proposal to the AFSG Executive Committee.

Successful applicants will also be asked to present the results of their research in a short webinar after the project completion date. The AFSG Executive Committee, and possibly other members of the AFSG, will attend these webinars.

Successful applicants may be asked to present their research project at an AFSG researcher session at the Current Advances in Gambling Research Conference.

Conflict of Interest

To ensure that decisions are fair and objective, reviewers, or members of the AFSG working group will not participate in review of or funding decisions of proposals submitted by:

- 1 A STUDENT THEY SUPERVISE;
- 2 A PERSON WHO HAS SUPERVISED THEM;
- 3 A PERSON WITH WHOM THEY HAVE COAUTHORED OR SHARED A GRANT IN THE PAST THREE YEARS;
- 4 A PERSON WITH WHOM THEY HAVE HAD LONG-STANDING SCIENTIFIC DIFFERENCES; OR
- 5 A PERSON WITH WHOM THEY HAVE A CLOSE PERSONAL FRIENDSHIP.

Degree to which the proposed methods will address the purpose of the research and answer the research questions. /25

Analytical Strategy (15%)	Describe the analytical strategy to be conducted including how the proposed analysis will address the purpose of the proposed research, and specifically how each of the research questions will be answered. Knowledge mobilisation plan (10%)	Briefly describe the knowledge mobilisation plan. Knowledge mobilisation can take many forms and should not consist solely of conference presentations and peer reviewed publications. For example, integrated knowledge mobilisation is an approach characterised by researchers and research users working together to shape the research process. In contrast, end of grant knowledge mobilisation includes typical dissemination and communication activities undertaken by most researchers (conference attendance, presenting research results, publishing papers, etc.). Budget and feasibility including team capacity and infrastructure (25%)	Project budget and timeline should be included in the downloadable template provided .
