1. ABOUT THE ACADEMIC FORUM FOR THE STUDY OF GAMBLING (AFSG)

The AFSG is a group of academic researchers in the UK dedicated to advancing the research needed to effectively prevent, reduce, and address gambling harm. The purpose of the AFSG is to act as a coordinated body to assert the importance of rigorous, independent research to prevent, reduce, and address gambling harm in the UK.

To accomplish its aims, the AFSG engages in several activities including, but not limited to:

- Responding to or initiating calls for evidence;
- Providing seed grants for promising research;
- Supporting independent gambling conferences;
- Public engagement; and
- Providing support for early-career researchers.

All AFSG activities and grants are funded from [regulatory settlements for socially responsible purposes](#). The Gambling Commission reviews and approves proposals for destinations of regulatory settlements. Funds are administered by Greo Evidence Insights (Greo).

3. APPLICATION OVERVIEW FOR POSTGRADUATE RESEARCH SUPPORT GRANTS

3.1 PURPOSE

Support is available to PhD students and to those who hold postdoctoral positions to offset the costs of conducting research that directly or indirectly informs efforts to address gambling-related harm.

3.2 ELIGIBILITY

3.2.1 Individuals and organisations.

Applicants must be registered as a PhD student or hold a postdoctoral research position with a UK university. Applicants must also be members of the AFSG. AFSG membership is free-of-charge and open to anyone affiliated or working with a UK university who is interested in conducting or co-creating independent research on gambling-related harm. Funding must be administered by a UK university.

3.2.2 Conflicts of Interest¹.

Applicants are required to complete and sign a Conflicts of Interest (COI) declaration form (see Section 9: Conflicts of Interest Declaration Form). **Applicants with Significant COIs are ineligible to receive funding.**

For the purposes of this funding opportunity, the following represent Significant COIs:

- if you have been an employee, contractor, partner, or principal working with the gambling industry² in the last 5 years.
- if you have investments³ in (valued at more than £5,000 overall) or commercial business interests associated with the gambling industry. This includes, but is not limited to stocks, bonds, commercial business interests such as partnerships, board memberships, etc.

- if you have provided expert opinion as part of a regulatory, legislative, or judicial process on behalf of the gambling industry in the last 5 years.
- if you or your research unit or organisation has received compensation, financial support, or research funding (not including regulatory settlement funds) or other sorts of gifts or compensation directly from the gambling industry to consult, advise, conduct research, or provide any other service in the last 5 years.

3.3 CONDITIONS

The research project under consideration must demonstrate that it is rigorous, independent research that directly or indirectly informs efforts to address gambling-related harm.

3.4 VALUE AND DURATION

Postgraduate Research Support Grants are valued at £3,300 and can last up to 12 months.

3.5 APPLICATION PROCESS

Expression of interest (EOI): Please send an email to afsg-funding@greo.ca by **11 April 2025** at 23:59 (BST) following the EOI instructions outlined in Section 7.1.

Potential applicants who do not send an EOI by the deadline **will not be considered for funding**.

Full application: Applicants should prepare an application according to the instructions in Section 6 and email it as a single PDF to afsg-funding@greo.ca by **16 May 2025**, at 23:59 (BST). The email subject should be "APPLICATION: AFSG Postgraduate Research Support Grant".

5. PROJECT REQUIREMENTS

5.1 REPORTING REQUIREMENTS

Successful applicants are requested to send a short Summary Report of their project to afsg-funding@greo.ca two weeks after the project completion date. A template for the Summary Report is provided in Section 10.

5.2 DELIVERABLES

In addition to the Summary Report, successful applicants will be asked to present the results of their research in a short webinar after the project completion date. The AFSG Executive Committee, and possibly other members of the AFSG, will attend these webinars.

Successful applicants may be asked to present their research project at an AFSG researcher session at the Current Advances in Gambling Research Conference.

5.3 OPEN SCIENCE

The AFSG encourages open science practices such as pre-registration, data sharing, open code, etc. Pre-registration of research hypotheses and data sharing are encouraged; however they are not required.

6. HOW TO PREPARE THE APPLICATION

The application should include the following sections in order in one single PDF document.

- Title page
- Outline of project
- Current funding situation
- Completed conflicts of interest form
- Letter of support from PhD supervisor or postdoctoral line manager

6.1 TITLE PAGE

- Please include the following:
 - Applicant name and contact information
 - Name and contact information of applicant's academic supervisor
 - Name of the UK University the applicant is affiliated with
 - Dated signatures of:
 - Applicant
 - Applicant's Supervisor

6.2 OUTLINE OF PROJECT (TWO PAGES MAXIMUM)

Provide a brief summary of the research project(s) you will be working on. Include information on the:

- Purpose of the research project(s)
- Methodology
- Status of the project(s) (i.e., ongoing, completed, or planned)
- Timeline of tasks
 - Start and end dates of the project(s)
 - A high-level estimated timeline of key tasks required to complete the research project (e.g., ethics application, data collection, analysis, writing, completion)
- Results of the project(s) either anticipated or realised

6.3 CURRENT FUNDING SITUATION

Please include:

- A brief summary describing any other sources of funding you will be in receipt of during the application funding period.
- A brief paragraph describing how the funds will help you complete the research project described above.

6.4 CONFLICTS OF INTEREST FORM

Each applicant must complete and sign the COI declaration form (see Section 9: Conflicts of Interest Declaration Form).

6.5 LETTER OF SUPPORT FROM PHD SUPERVISOR OR POSTDOCTORAL LINE MANAGER

Please include a letter of support from your PhD supervisor or postdoctoral line manager (one page maximum).

7. HOW TO APPLY

7.1 EXPRESSION OF INTEREST (EOI)

Please send an email to afsg-funding@greo.ca by 11 April 2025 at 23:59 (BST) indicating:

1. applicant name and contact information;
2. name and contact information of applicant's academic supervisor; and
3. the university to which funds would be distributed through (if successful).

The email subject should be "EOI: AFSG Postgraduate Research Support Grant".

Please note, **applicants who wish to be considered for a grant must submit an EOI by the deadline above.**

7.2 FULL APPLICATION

The full application should be sent as one continuous PDF email attachment to afsg-funding@greo.ca by 16 May 2025, at 23:59 (BST). The email subject should be "APPLICATION: AFSG Postgraduate Research Support Grant".

8. REVIEW PROCESS

A working group of at minimum two AFSG members will review and evaluate applications according to the following criteria:

- Overall fit of research project(s) with the purpose of the funding program
- Quality of proposed research
- Need
- Letter of reference

Applications will be scored on a scale of one to five for each of the criterion above using the following scale:
